#### Did You Know....

Florida is home to over 500 species of birds (credit: Florida Ornithological Society), and this time of year can be particularly exciting for birders. As birds migrate from all over the world to find refuge in our temperate climate, you may see and hear new birds and birdsong in your own backyard. ## **Wellness Toolbox**

It's nice to be nice. But when being nice starts to intrude on our peace of mind, or gets in the way of taking care of our own needs, it is time to re-evaluate and consider something new.

"Our Delray Villa neighbor Bonnie"

what she felt would be important for our January Plat Chat, especially with our current events ... so here goes: Bonnie's always got a note of laughter in her voice! The two things that amaze people about Bonnie is how much joy for life she shares with others, all of us, as neighbors in Delray Villas and how determined she was, as a child alone, to live.

> Bonnie was the only member of her family to survive the Holocaust.

From the age of 9 to 14 she hid in the woods, barns & attics. At first with her family, but then they didn't survive, leaving her as a preteen, alone. She had to learn quickly to survive, sometimes wearing a cross and speaking Russian. The Nazis took her parents & brother but missed her hiding under a mattress in an attic. When the war ended, she landed in a children's relocation camp. She was given the choice to go to the United States or Israel. Bonnie's mother made her memorize the name of a cousin in the United States, so that's where she went.

Bonnie is known not to be bitter. In her own words, she says 'I am grateful. I made it. Life is a wonderful thing and I've had the chance to live it. I've got a future.

Hope you get the chance to meet and know Bonnie, one of Delray Villas loveliest residents. A local newspaper "The Jewish Journal" printed her story on the cover of the May 10, 2023 issue. If you'd like to read the online version, please ask Chelle Lukens or Nancy Grasso.

## The LEGAL CHIT- CHAT By: Alan Jay Lewis, Esq.

One of the most significant transactions that a person may be involved with is the Selling or Buying of a Home.

LAST MONTH I DISCUSSED THE SPECIAL CONSIDERATIONS FOR A SELLER OF A HOME.

THIS ARTICLE WILL DISCUSS SOME IMPORTANT ISSUES FOR A BUYER OF A HOME TO CONSIDER:

Individuals who are interested in Buying a Home, usually spend some time searching the Internet and/or speaking with friends, family and Broker/Realtors who may be able to help the Buyer find a Home that is in a particular area or community and meets the important needs of the Buyer. Sometimes a Buyer may find a Seller, through word of mouth, who has not "listed" the Seller's Home with a Broker/Realtor.

It is important to note that <u>most Buyers</u> decide that they are <u>not willing</u> to enter into any Agreement with a Broker/Realtor to pay a fee for the Broker/Realtor's services in helping the Buyer to purchase a Home; in such case, the full Broker/Realtor's Commission <u>the Commission for Broker/Realtor services</u> is to be paid by the Seller of the Home.

When a Buyer finds a Home that they are interested in purchasing, the potential Buyer has to submit an OFFER in writing to the Seller. In most situations, the Buyer's OFFER describes all the terms and provisions, and it is usually incorporated within a document called an "As-Is" Residential Contract for Sale and Purchase. The OFFER is presented by the prospective Buyer to the Seller and if the OFFER is "accepted" by the Seller without any material changes, ...guess what,... the parties, at that point in time, have entered into their Contract for the Sale and Purchase of the Home.

For purposes of simplicity, I will, in the remainder of this Legal Chit-Chat Article, simply refer to the "As-Is" Residential Contract for Sale and Purchase, as the parties "Contract."

Most people, understandingly so, focus primarily on the Sales price in the Contract as the deciding factor regarding whether they want to purchase a Home. While the Sales price is undoubtedly a very important part of the Contract, it is one part of the Contract; however, the Contract contains many other provisions that are also very important—to name a few such as, what items of Tangible Personal Property are being sold with the Home; the Closing Date; whether the Contract is contingent on the Buyer obtaining a Mortgage Loan from a Bank or other lending institution, or whether the transaction is simply an "All cash" transaction; what period of time the Buyer has to conduct all of the Buyer's inspections of the Home, i.e.., roof, plumbing, Air Conditioning and Heating, Electrical, structure/foundation, termites and mold, etc.; the fact that there has to be licensed Inspectors who examine the premises; the Seller's obligation to make repairs and the Buyer's right to cancel the Contract within a stipulated number of days after the timely inspections are made by the Buyer, if the Buyer is dissatisfied with the condition of the Home; how the costs and expenses that are associated with the Sale and Purchase will be allocated as between the Seller and the Buyer; what happens to the "down payment" paid by the Buyer and deposited in Escrow with an Escrow Agent if the Buyer defaults under the Contract; and what remedies does the Buyer have if the Seller defaults under the terms and provisions of the Contract.

Due to the fact that a purchase of a Home could be the single largest financial undertaking of a individual, it is, important that the potential Buyer have a competent individual, who is well-versed in residential real estate transactions, to review the potential Buyer's Offer and make revisions, if necessary, BEFORE the Buyer's Offer is presented to the Seller...and also review any changes/modifications made by the Seller to the Buyer's Offer, which said changes/modifications are known as the Seller's Counter Offer. In Florida, it is quite common for Broker/Realtors to prepare the prospective Buyer's OFFER; a word to the wise, Broker/Realtors are not Attorneys and cannot give the prospective Buyer any "legal advice." If the prospective Buyer wants actual "legal advice" about the OFFER and the terms and provisions of the Contract, the prospective Buyer will need to hire an Attorney who is knowledgeable in this field and has handled many real estate sale and purchase transactions as part of his/her law practice.

After the Contract is signed by both the Buyer and the Seller, a Title Company is designated to handle the Closing, as the Closing/Settlement Agent. The Title Company examines the status of the Title to the Seller's Home and the Title Insurance Company determines if the Title that will be transferred to you, as the Buyer [at the Closing] is "marketable." In addition to the fact [noted above] that a Broker/Realtor cannot give you, the Buyer, legal advice, a Title Company also cannot give any "legal advice."

The last basic part of the Purchase of your Home is the Closing/Settlement of the transaction. This is when the Seller, transfers and delivers, to you, the Buyer, a Warranty Deed to you, in exchange for the payment by you of the balance of the Purchase price. The receipt by the Buyer and the recording of the Warranty Deed in the Official Public records of the county where the real estate is located vests in you, as the Buyer, all the "ownership rights to the Home." Your Attorney [if you hire an Attorney to represent you at the Closing] or the Title Insurance Company can explain the Closing Documents/Settlement Statement to you, the Buyer, and that process will describe to you what costs/expenses/fees/taxes relating to the sale are chargeable to you, as the Buyer.

## 2023: A Record Breaking Year for Sea Turtles!

The Florida Fish and Wildlife Commission (FWC) counted 133,941 loggerhead sea turtle nests. This is 30,000 nests more than average and breaks a record set in 2016! Green turtle nests were record breaking as well: 76,645 nests counted, more than 20,000 nests over the previous high record set in 2017! Of the 7 species of sea turtles worldwide, 4 nest in the Florida Keys: the loggerhead, green, leatherback, and hawksbill turtles. The Florida Keys have many critical nesting sites; you may have seen areas of the beach marked off to protect their nests.





Female sea turtles do not nest every year. When they do, they typically lay 3 to 5 nests, although leatherback turtles may nest up to 11 times during a single nesting season. Frequent nesting is important because its estimated only 1 in 1,000 hatchlings survive to maturity. Sea turtles travel thousands of miles over a lifetime, and the females usually return to the same beaches where they were born. The Marathon Sea Turtle Hospital frequently outfits sea turtles with satellite-tracking transmitters as part of the Tour de Turtles Race to follow their journeys after rehabilitation. This years long distance winner is Bella, a

Hawksbill turtle who logged over 1,800 miles in under a month from her release in Puerto Rico to the Bahamas! (That's 60 miles per day!).

## The "Squirrel next door"

Despite being one of our most conspicuous and common mammals, the Eastern gray squirrel (Sciurus carolinensis) is often overlooked, their fascinating lives hidden in plain sight. This rodent species is equipped with a variety of adaptations and quirky behaviors that help them survive in their environment. Their large eyes—often described as "beady"—allow for the keen vision needed to keep watch for lurking predators, of which there are many. Squirrels are important prey [CREDIT: unsplash.com, TLStoot] animals for a variety of raptors, such as hawks and owls, as well as snakes, foxes, coyotes, bobcats, and more.



When a predator does get too close, Eastern gray squirrels will make sure that everyone knows. If you have ever found yourself suddenly within a squirrel's "personal space," chances are you have heard their unique vocalizations and seen the quick swishing of their tail as they bravely and intently watch your every move. Squirrels communicate through the use of vocalizations, visual cues and body language, as well as through scent. They can even detect potential danger in an area by catching a whiff of another squirrel's elevated stress levels. Gray squirrels could give any circus performer a run for their money. The next time you encounter one of these acrobats, take some time to appreciate their grace and agility, as they make daring leaps from branch to branch. An Eastern gray squirrel's sharp claws allow them to cling securely to the bark of trees, and their specially adapted legs allow their feet to turn backwards, enabling them to climb UF headfirst down a tree, by Zahir Ringgold Cordes Posted; November 29, 2023.
